IT IS UNDERSTOOD AND AGREED that said contest shall be with gloves that are approved by the Commission and furnished by the PROMOTER. All officials of the contest shall be persons licensed by the Commission. If the Commission shall decide that the FIGHTER did not enter into this contract in good faith or is not honestly competing, or is guilty of an act that is detrimental to fighting, it is agreed that the fighter shall not be entitled to the compensation listed above or any part thereof and those decisions of the Commission shall be final.

If FIGHTER shall fail to appear or make weight or is not in physical condition to fight as determined by a duly licensed physician, the Commission reserves the right to fine, suspend or take any other reasonable action against such FIGHTER.

IT IS UNDERSTOOD AND AGREED the fighter _____ weight class of _____ pounds compete against _____ whose weight class is _____ pounds.

IT IS UNDERSTOOD AND AGREED that if the FIGHTER enters into another contest prior to the one contracted for and lessens his present value as an attraction, the PROMOTER shall have the option to modify or cancel this contract. The Commission reserves the right to fine, suspend or take any other reasonable action against the FIGHTER.

IT IS UNDERSTOOD AND AGREED that the PROMOTER is to make all necessary arrangements for said contest.

IT IS UNDERSTOOD AND AGREED that all parties to this contract hold valid licenses with the Commission.

IT IS UNDERSTOOD AND AGREED that in the event of any dispute arising from this contract, the Commission may intercede in said dispute and all decisions rendered by the Commission shall be binding on all parties.

IT IS UNDERSTOOD AND AGREED that this contract must be given to the Commission before the start of weigh-ins. This agreement is subject to the provisions of the Pascua Yaqui Athletic Commission and to any future amendments of them.
