- 1. Notice of Election, Monday, May 18, 2015**
- 2. Voter Registration & Absentee Ballot Request Form Deadline, Monday, June 15, 2015, 4:30 p.m.**
 - Note: The Voter Registration & Absentee Ballot Request Form must be received by the Secretarial Election Board Chairperson located at 10000 East McDowell Road Scottsdale, Arizona 85256 before the Deadline on Monday, June 15, 2015, 4:30 p.m.
 - Note: Remember, if you do not properly register with the Election Board Chairperson, you will not be allowed to participate in the Secretarial Election on Tuesday, July 14, 2015.

4. Deadline to File a Challenge to the Registered Voter's List, Friday, June 19, 2015, 12:00 p.m.

- Note: Any individual whose name does not appear on the official registered voters list can claim the right to vote by presenting a written claim to the Secretarial Election Board Chairperson. The right to vote of anyone whose name is on the list may also be challenged by presenting a written claim to the Election Board Chairperson.
- Note: Such claims or challenges must be delivered to Election Board Chairperson at: Bureau of Indian Affairs, Salt River Agency, 10000 East McDowell Road, Scottsdale, AZ 85256 or by fax at (480) 421-0807. Claims and challenges must be presented to the Secretarial Election Board Chairperson before 12:00 p.m., Friday, June 19, 2015. The Election board shall meet on the same day to rule on any claim or challenges and any decision shall be final.

6. Absentee Ballot Deadline, Friday, July 10, 2015, 4:30 p.m.

- Note: All absentee ballots must be received by the Secretarial Election Board Chairperson located at 10000 East McDowell Road, Scottsdale AZ 85256 no later than 4:30 p.m., Friday, July 10, 2015.

9. Deadline to File a Challenge, Friday, July 17, 2015 12:00 p.m.

- Note: Any eligible voter may challenge the election results within three days following the posting of the results of the elections. The challenge must be in writing, must be filed with the Secretary of the Interior through the Election Board Chairperson, and must give the grounds for the challenge with substantiating evidence. If, in the opinion of the Secretary, the objections are valid and warrant a recount or new election, the Secretary shall so order. The results of the recount or new election shall be final.
