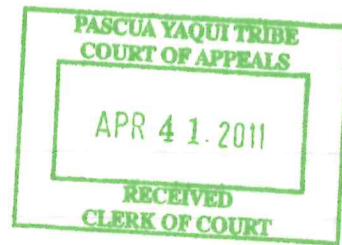

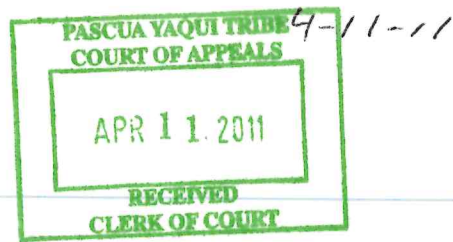




YOUR HONOR,

IT HURTS ME ALOT TO WALK TO THE COURTS AND PHARMACY. I AM PAYING THE BILLS THE COURT ORDERED ME TO BEING HOME BOUND AND NOT BEING ABLE TO EAT 3 MEALS A DAY AND HAVE TO EAT ONLY WHEN I AM HUNGRY IS MORE DEPRESSING TO ME. IF YOU SEND A SOCIAL SERVICE WORKER TO MY HOME SHE WILL SEE MY PANTRY, FREEZER AND REFRIGERATOR EMPTY. DR BENTERIA TOLD ME I WAS GOING TO DIE AND I EXPECTED DEATH. I HAD MY LAST RIGHTS. 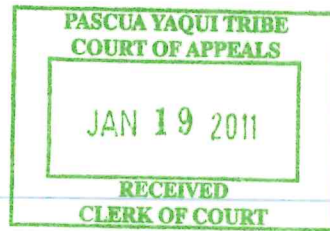

IT WAS HARD FOR ME TO FUNCTION BECAUSE I WENT EVERY MORNING FOR RADIATION. THE NAUSEA CAUSED 4 HEMORRHOIDS, WHICH WERE REMOVED ON 12/23, 2010 AFTER I HAD POSTPONED 2 TIMES FOR LACK OF TRANSPORTATION. I MISS A LOT OF DOCTORS APPOINTMENTS BECAUSE THE INSURANCE REQUIRES 4 DAYS NOTICE TO TRANSPORT ME. MY BILLS ARE BACKED-UP BECAUSE I CAN NOT GO PAY THEM. I GO WITHOUT FOOD BECAUSE OF LACK OF TRANSPORTATION. I RECEIVE \$713.00 FROM SOCIAL SECURITY DISABILITY AND \$41.00 FOOD STAMPS. WITH \$41.00 I CAN NOT BUY MY SPECIAL DIET FOOD FOR THE MONTH. SHE PERJURED HER SELF SAYING SHE IS AN ENROLLED MEMBER AND HER RESIDENCE AT THE TIME. SHE HAS AN INCOME. SHE ONLY ASKED FOR ALL THE VEHICLES AND FURNISHURE SHE CAN SELL. I WAS TOLD BY ENROLLMENT ONLY THE COURT CAN ASK FOR HER

ENROLLMENT INFORMATION. IF THE COURT DOES NOT SIDE WITH ME, I MIGHT AS WELL PUT MYSELF IN A HOSPICE AND GIVE UP ON LIFE, BECAUSE I WOULD BE IN VIOLATION OF THE COURT, NOT BE ABLE TO PAY MY BILLS AND THE ONES THE COURT ORDERED, BECAUSE OF MY HEALTH I NEED FOOD, WATER, GAS, LIGHT, TRANSPORTATION, HOME, MY FURNISHER AND MY SOCIAL SECURITY CHECK. SHE CAN NOT PROVE TO THE COURT OR SOCIAL SECURITY SHE CAN NOT WORK. FOR THE PAST FOUR YEARS, I SUPPORTED THE HOUSEHOLD WITH MY LITTLE CHECK. I PREY ACTION AND A HEARING TAKES PLACE A.S.A.P. 

On Nov 12, 2010, the Appellant Rafael Madrid filed a Notice of Appeal to this court, appealing a ruling by Associate Judge Melvin Stoof. Appellant Madrid is contesting (a) the judge's distribution of community property assets and the award of spousal support; and (b) requesting an immediate stay of the lower court's order.

The Appellant in his Notice of Appeal requests the Appellate Court to expedite our review of his case and further requests a stay of the Tribal Courts' order. This court finds good cause to issue a stay of the lower court's order pending review of the appeal.

Accordingly, the Tribal Court's Default Order for Distribution of Marital Property, Allocation of Debts, and Order for Spousal Support, dated October 22, 2011, is stayed pending review of this case by the Court of Appeals.
