The Court may or has made such other temporary orders that are in the best interest of the case.

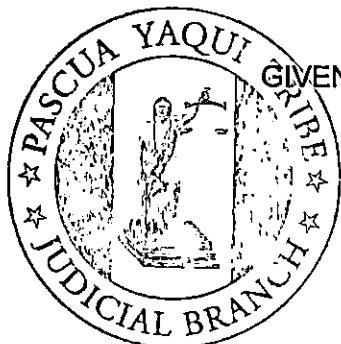
You may appear at the hearing and be represented by counsel at your own expense.


