ORDER FOR CLOSURE AS WARDS OF COURT

The above matter came before this Court for a review hearing on October 6, 2022. Appearing were Madelynn Franklin, prosecutor's office, Carmen Solis, Social Services, the father, Jose Maria Moreno III, failed to appear, and the mother, Luisa G. Soto, appeared without counsel. The court, after reviewing all pleadings, notices, and hearing testimony, finds it has continuing jurisdiction over the parties and subject matter. Because the mother has addressed the issues which led up to the removal of the children from the home, and Social Services recommends that the children be returned to the sole custody of the mother to serve the children's best interest, the court should close the current child welfare case, drop the children as wards of the tribal court, and Pascua Yaqui Social Services should be relieved of any further legal duties regarding the child's health, safety, and welfare. The tribe concurs with the recommendations. As to Mr. Moreno, the court shall reschedule the review hearing to allow service by publication. Time limits are waived.

IT IS THEREFORE ORDERED that the court grants the relief requested by Social Services, the court shall drop this as a child welfare matter, the children, Enrique Moreno, DOB 11/08/2005 and Yessenia Moreno, DOB 11/08/2007, shall no longer be wards of the court, and he shall be returned to the sole custody of their mother, Luisa G. Soto. Because there is no further necessity for intervention by the Pascua Yaqui Social Services Department, The Pascua Yaqui Social Services Department shall no longer be responsible for the child's health, safety, and well-being, and the child welfare case shall be closed AS TO THE MOTHER ONLY.

IT IS FURTHER ORDERED that the Court shall reschedule the father's review hearing to DECEMBER 8, 2022 AT 11:30 A.M.

ORDER FOR CLOSURE AS WARDS OF COURT - 1

IT IS FURTHER ORDERED that any Social Services' report or updates as to the father shall be submitted no later than December 1, 2022.

IT IS FURTHER ORDERED that the Tribe shall provide notice of hearing to the father by publication. Proof of publication shall be submitted to the Court prior to the hearing.
