You may appear at the hearing and be represented by counsel at your own expense.



VIOLATION OF THIS ORDER IS SUBJECT TO PROCEEDINGS FOR CONTEMPT OF COURT PURSUANT TO PASCUA YAQUI TRIBAL CODE TITLE 4, CHAPTER 4, SECTION 160 THROUGH 180. THE COURT MAY FIND THE PARENT, GUARDIAN, OR CUSTODIAN IN CONTEMPT FOR FAILURE TO APPEAR AT A COURT HEARING OR FOR FAILURE TO FOLLOW COURT ORDERS.
