The Court may or has made such other temporary orders that are in the best interest of the child (ren).


You may appear at the hearing and be represented by counsel at your own expense.

ALL HEARINGS ARE CONDUCTED IN ENGLISH. IF YOU REQUIRE AN INTERPRETER YOU WILL NEED TO MAKE ARRANGEMENTS AT YOUR OWN EXPENSE TO HAVE ONE PRESENT AT THE TIME OF HEARINGS.

VIOLATION OF THIS ORDER IS SUBJECT TO PROCEEDINGS FOR CONTEMPT OF COURT PURSUANT TO PASCUA YAQUI TRIBAL CODE TITLE 4, CHAPTER 4, and SECTION 160 THROUGH 180. THE COURT MAY FIND THE PARENT, GUARDIAN, OR CUSTODIAN IN CONTEMPT FOR FAILURE TO APPEAR AT A COURT HEARING OR FOR FAILURE TO FOLLOW COURT ORDERS.
