The Court may or has made such other temporary orders that are in the best interest of the child (ren).

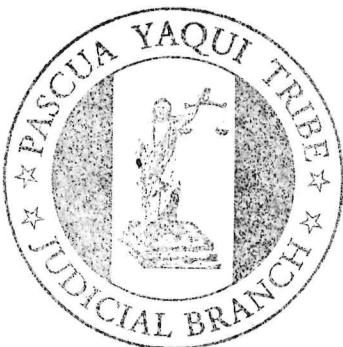
You may appear at the hearing and be represented by counsel at your own expense.



THE COURT MAY FIND THE PARENT, GUARDIAN, OR CUSTODIAN IN CONTEMPT FOR FAILURE TO APPEAR AT A COURT HEARING OR FOR FAILURE TO FOLLOW COURT ORDERS.
