13 process. The Court finds good cause to continue the Guardianship Hearing.


14 **IT IS ORDERED** that the Guardianship Hearing is continued to **Thursday, December**  
**5, 2024, at 11:00 a.m.**


15 **IT IS FURTHER ORDERED** that the Guardianship Hearing set for Wednesday, October  
16 30, 2024, at 10:00 a.m., is **VACATED**.


17 **IT IS FURTHER ORDERED** that the Petitioner(s) shall provide a notice by publication to

20 **notice of the Guardianship Hearing. It must provide "the name of the court, name of the**  
**child[ren], the date of the filing of the petition, . . . , and the object of the proceeding in general**  
**terms, . . . ."**
