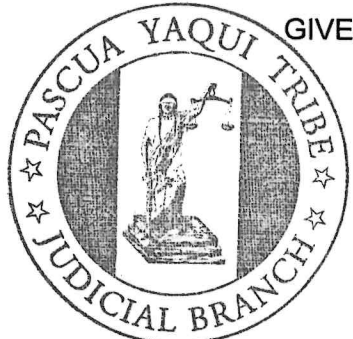
You may appear at the hearing and be represented by counsel at your own expense.
