22 **SHALL RESULT IN YOUR IMMEDIATE ARREST FOR CONTEMPT.**

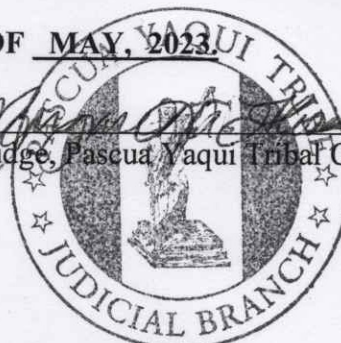
