ORDER

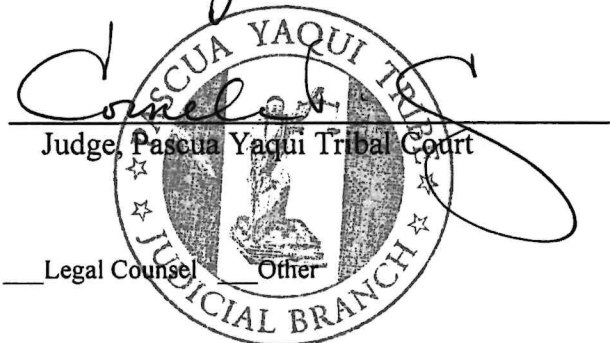
The above matter came before the Court for the continued Trial hearing on the Preliminary Injunction Order on this 18<sup>th</sup> day of June, 2025. The Plaintiff appeared without legal counsel; the Respondent failed to appear.

The Court finds that, notice of today's date and time of hearing was sent to the Respondent by certified mail, return receipt requested to no avail and the return receipt indicates that the notice was undeliverable as addressed; that the Plaintiff states that the address is correct as her sister resided at that address and further adds that she has no other address for the Respondent; that the Court will continue the hearing to allow the Plaintiff to serve the Respondent by notice by publication as there is no other address in which to serve the Respondent and pending the continued hearing, the Preliminary Injunction will remain in place.
